(1) The 28 municipalities with an “*” have the original cigar pricing policy that requires single cigars be sold for at least \$2.50; two-packs for at least \$5.00; three-packs for at least \$7.50 and 4-packs, or larger, at market rate (no minimum). The remaining municipalities also require that single cigars be sold for at least \$2.50 and all multi-packs be sold for at least \$5.00 at retail, except Boston and Revere are \$2.50 instead of \$5.00. First to enact: Boston on 2/2/12.

(2) Cigar: Any roll of tobacco that is wrapped in leaf tobacco or in any substance containing tobacco with or without a tip or mouthpiece not otherwise defined as a cigarette under Massachusetts General Law, Ch. 64C, §1, Para. 1.
