LOCAL STATE ADVISORY COMMITTEE

The Local State Advisory Committee (LSAC) is made up of local and state officials who are involved with Emergency Preparedness. It is this group that discusses how the CDC’s Public Health Emergency Preparedness (PHEP) Grants are to be used. In February of this year, CDC issued the Funding Opportunity Availability (FOA) for next grant year, and that is currently being reviewed. As it stands now, the various public health emergency preparedness regions will be asked to provide consensus votes by the end of March.

One issue that is taking up much of LSAC’s time is the formation of Health and Medical Coordinating Councils (HMCC). The process is at varying stages throughout the Commonwealth, with some areas having an easy time with the matter, while others running into problems. Local health officials are encouraged to take an active part in the HMCC formation to ensure that the public health issues are adequately addressed.

Perception is everything!? It’s perceived that with all the news and announced planning, that we as a state and nation have a handle on this epidemic; however, as each of us read the **local** newspaper each week, we read another obituary or statistic of losing someone to opioids. False perceptions, that we have a handle on this epidemic, is unfortunate. Perception isn’t everything but reading the statistics are!

Beyond serving as President of MHOA, I serve as a Public Health Director. **Everytime, I hear that we have a statewide public health epidemic related to opioids, I think “What are we doing as local public**

health”; since it’s a public health issue and we see it in each our communities.

I bet many of you have **perceived** this same thing and have the same perception that the State Department of Public Health, the Governor, etc. are handling this! **Having experienced opioid addiction with a family member and losing a 26 year old cousin to it,, we must act** as public health professionals and be part of puzzle towards addressing this issue.

The MHOA executive committee unanimously voted to form a steering committee for 2016 that will plan and produce an opioid resource / toolkit for local

guideline to follow. This tool kit may suggest forming a substance abuse coalition and task force and how to form one; how to build a treatment and recovery resource guide for families to refer to; providing real statistics from MDPH related to evidence based recovery rates for **ALL** treatment types, programs, and facilities; (Request has been made to DPH for this); working with first responders for NARCAN training; sharing best practices from other communities, etc. If you would like to serve on this steering committee please **email** me! I approached the Association of Food and Drug Officials (AFDO) and our regional rep from the US Food and Drug Administration (FDA) about adding the MHOA Conference to there training list for there FDA Retail Food Standard grants. They approved MHOA's conference as a possibility to apply for funding.

This only applies to communities that are enrolled in the FDA's [Voluntary National Retail Food Regulatory Program Standards](#) and if they apply for the annual Cat 3 training grant. (The MHOA Conference will be an additional training option to apply for)

AFDO supplies a list each year of possible trainings and seminars you can send you and your staff to each year with the grant money. The list includes FDA courses, seminars, conferences, the MA Food PHIT training course, etc. Now it will have the MHOA Conference as well.

Coalition for Local Public Health

The Coalition for Local Public Health, formed in 2002, represents the 5 statewide public health organizations (MHOA, MAPHN, MEHA, MPHA, MAHB). Leadership of each of the organization meets monthly to identify issues and strategies to best advocate, promote and strengthen local health within MA. Collectively we represent over 3000 members. MHOA has participated in the Coalition since the group formed.

2015-2016

We began this year holding multiple strategic planning sessions to update our major goals and objectives for the year aimed at ways to better provide support and resources to local public health. Ideas that were generated from these sessions have been driving the work of the CLPH this year. Some of the priorities we are working on include:

Orientation Process For New Public Health Staff And Board Members

After identifying inconsistencies that exist on how new public health staff become oriented in MA, the CLPH organizations are working collectively to produce a pilot, 1 day orientation program which will be offered in June. The 6 hour standard training will be offered to all new staff, emphasizing core functions, essential services, legal responsibilities and existing resources. It will also make them aware of what is available to them through the CLPH organizations, DPH, DEP and others. Support for the project is being offered from MDPH and BU. Our hope is that this will fill an identified gap.

Assisting DPH in developing the Scope and work of the Office For Local Health (OLRH)

The CLPH has been working with DPH to support them in establishing the OLRH. DPH has been supporting our efforts and provided continued financial support for each of the 5 organizations and assistance with obtaining an administrative support person for the CLPH. We are also working with the Office for Local and Regional Health to develop a system and process to keep contact lists of local public health department staff current, to help improve communication between local health, DPH and others.

Legislative Advocacy For Various Bill Impacting Public Health

CLPH's policy subcommittee continues to review and provide input and advocacy for numerous legislative bills impacting local health. Support for passage of bills impacting local health is promoted through all 5 CLPH organizations

CLPH re-filed the MRC Liability Protection bill through Senator Moore and Representative Garlick and continued to assess the scope of the problem and protections which currently exist. We also determined the perception which MRC units have on the impact that not having a specific state bill for MRC protection has on the ability for MRC's to recruit and retain new members. A survey was developed and sent out to all MRC leaders and info obtained was evaluated.

Some of the other bills which we have either been tracking or advocating for include: promoting the expansion of housing courts, promoting funding for DPH budgets including support for MA in Motion, and a tracking a number of bills circulating which could if passed, preempt Boards from regulating certain public health concerns on the local level.

Trainings

CLPH organizations continue to promote workforce development through numerous trainings held throughout the year.
