# **Community Engagement Overview + Goals**

- To engage with the community, increasing awareness around settlement funds and other town opportunities for involvement
- To involve people with substance use disorder and other lived experience in decision-making processes
- To be as inclusive as possible, ensuring all cultural, ethnic, and lingual communities are included
- To create a model practice with community engagement event templates which towns can duplicate and individualize to the needs of each area
- To be thoughtful and intentional with the process to not create more harm for community members

### Timeline + Process


March-May: Convened advisory group, design team, + prep
