JOB POSTING

Title: Regional Health Inspector

Location: The position is based out of the Town of Rockland, MA, but provides regional coverage in all

towns included in the coverage area.

Coverage Area: The South Shore 5 Public Health Alliance (SS5PHA) comprises the towns of Hanover,

Marshfield, Norwell, Pembroke, and Rockland.

Funding: This position is grant-funded and is subject to appropriation under the Massachusetts Public

Health Excellence Grant for Shared Services, Department of Public Health

Hours: 15 - 19 hours per week

Hourly Rate: \$32 - \$45/hour. Salary commensurate with experience.

Position Purpose:

This position supports the South Shore 5 Public Health Alliance to promote the health and wellbeing of residents through the execution of a variety of environmental, community, and public health program responsibilities. The Regional Health Inspector will be responsible for performance of technical and inspectional work to promote and protect the public health of the community through enforcement of state and local laws and regulations. The role will also provide support to ongoing preventative health programs and collaboration between public health nurses and existing inspectional and human services staff across the 5 participating communities within SS5PHA.

Scope and Judgment: The Regional Inspector assists with the effort to provide public health services and support the communities of: Hanover, Marshfield, Norwell, Pembroke, and Rockland. Coverage across the five towns may vary and is dependent on need. The Regional Health Inspector performs varied functions requiring a specialized and working knowledge of environmental health and sanitation, as well as community and local public health operations. Exercises judgment and initiative and is willing to help develop and define new procedures. This position will also contribute to regional-level initiatives and programs.

Supervision Received: The Regional Health Inspector works under the general administrative direction of the Health Directors of SS5PHA in accordance with applicable provisions of the Massachusetts General Laws, Board of Health regulations, and town bylaws, state, and federal regulations.

Job Environment

- This role will report to the Rockland Board of Health as the host community with regular inspectional activities completed in person across SS5PHA communities as core responsibilities dictate.
- Operates telephones, computers, and all other standard office equipment.
- Constant contact with community organizations, town residents, town department employees, vendors, and state and federal agencies. Contacts are made by phone, in person, by email, or by written correspondence.

 Inspection work can be conducted in the field, sometimes under adverse environmental conditions.

Essential Functions:

(The essential functions or duties listed below are intended only as illustrations of the various types of work that may be performed. The omission of specific statements of duties does not exclude them from the position if the work is similar, related or a logical assignment to the position.)

- Enforces federal, state, and local laws and regulations pertaining to public health & safety.
- Inspects food service establishments, day care centers, nursing homes, food distribution programs, retail food stores and special events for compliance with state sanitary code; monitors food establishment test results.
- Conducts food establishment complaints and collaborates with Public Health Nurses on foodborne illness investigations, contacts state officials, consults with physicians and lawyers, and submits required reports and final analysis to appropriate state and local departments or agencies.
- Collaborates with Health Directors and Health Agents to report violations of applicable regulations using a variety of reporting methods, such as inspection reports, court complaints, tickets, and order letters.
- Takes corrective action, issues instructions to responsible parties regarding changes to be made and performs follow-up inspections to ensure compliance with regulations.
- Assists Health Directors and Health Agents in preparing order letters seeking enforcement
 of violations. Prepares documents in support of public health hearings and department
 enforcement actions, hearings, legal actions as well as presentation of public health
 rationale for enforcement in court.
- Supports Health Departments to collaborate with the Massachusetts Department of Health and the Department of Environmental Protection as required to enforce regulations.
- Educates food handlers on prevention of foodborne illness across residential kitchens, food establishments, daycares, etc.
- Investigates and responds to complaints and nuisances relating to unsanitary, dangerous and/or unsafe living conditions and environments, rodent and insect control, rabies, drinking water and septic systems, as directed by the Health Department.
- Maintains knowledge and expertise in relevant areas of public health, housing, and environmental issues in order to maintain required licenses and certifications and changes in pertinent public health laws and regulations as well as enforcement practices.
- Assists and participates in the organization and development of the department's emergency preparedness programs.
- Assists with the development and implementation of various public health education programs.
- Performs other duties and works on special projects as assigned or directed.

Minimum Entrance Requirements:

Education, Training and Experience:

Bachelor's degree in environmental science, public health or related field; and one to three (1-3) year(s) of experience in a related field; or any equivalent combination of education and experience.

Current certification or eligible to become certified as a:

• Registered Sanitarian (RS) or equivalent within 6 years of hire, in alignment with the Office of Local & Regional Health's (OLRH) Workforce Standards.

- Completion of the Foundations for Local Public Health Practice course required within 18 months
 of hire.
- Food inspection certifications ServSafe, MAPHIT.
- Certified Pool Operator (CPO) within one year of hire.
- Housing inspection training within one year of hire.
- Valid driver's license and personal transportation required.

Preferred Qualifications:

- MA Title 5 Septic System inspection certification preferred.
- Soil Evaluator certification preferred.

Excellent interpersonal skills required. Demonstrated ability to interact professionally with culturally diverse individuals.

Knowledge, Ability and Skill:

Knowledge: Thorough knowledge of state environmental code, food service regulations, and all other laws, rules, and regulations pertaining to public health and sanitation. Thorough knowledge of State septic system guidelines; working knowledge of current inspection and control procedures.

Ability: Ability to meet and work with municipal colleagues and the public effectively and appropriately; ability to effectively handle problems in the field and during emergencies; ability to communicate clearly, both orally and in writing; ability to operate a computer; ability to maintain confidential information; ability to maintain, manage, and organize records; ability to establish and maintain effective working relationships with municipal employees, town officials, state regulatory agencies and disgruntled members of the public. Ability to manage multiple tasks in a detailed and organized manner. Ability to enforce laws and regulations in an impartial manner and consistent manner.

Skill: Excellent organizational skills; Intermediate or higher-level skill in Microsoft Office suite; proficient oral and written communication skills.

Physical Requirements

(The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.)

Physical Skills: Work requires some agility and physical strength, such as moving in or about construction sites or over rough terrain, or standing or walking most of the work period. Occasionally, work may require lifting objects and carrying them. There also may be a need for the employee to stretch and reach in order to retrieve materials.

Motor Skills: Position requires minimal motor skills for activities such as: operating a personal computer and/or most other office equipment, typing and/or word processing, filing, moving objects, sorting of papers, or operating a motor vehicle.

Visual Skills: Position requires routine reading of documents and reports for understanding. The employee is required to determine color differences.
