HISTORY OF MHOA

Massachusetts Health Officers Association (MHOA) was formed to meet a local need. The foundations of MHOA began in 1950, when a group of health officials from cities and towns north of Boston began meeting together several times a year on a voluntary basis for the purpose of contributing their experiences for a better understanding and servicing of local health department practice and administration. This group became known as the North Metropolitan Health Officers and Agents Association. State Health Department officials took an interest and attended their meetings.

Because of the activities of this group and their interest in public health, many local health officials from communities south of Boston indicated a desire to become members of the group. On November 17, 1954, the name was changed to the Metropolitan Health Officers Association and included health officials from the Northeastern and Southeastern Health Districts of the State.

Interest and membership expanded to include local health officials west of Boston. In 1962, the name was changed to the Massachusetts Health Officers Association and membership was open to health officials throughout the state. The date of incorporation for MHOA was February 4, 1972. Over the years, the association has attracted many new members.

As of April 2025, regular MHOA membership embodies any person employed as a Director, Agent, Public Health Nurse, or Inspector of a regional or local municipal agency for the purpose of carrying out the public health mandates of that agency; or any person certified by the Board of Certification of Health Officers. Associate members include those individuals that do not meet the requirements of regular membership but wish to support and advance the objectives of MHOA. We are also proud to have a number of emeritus and retired members. Membership qualifications may change in the near future - updates are available on the MHOA website.

MHOA is the official state affiliate of National Association of County and City Health Officials.

DISTINGUISHED SERVICE AWARDS

John D. Crowley Award

This award is in honor of the late John D. Crowley, who served the City of Cambridge as Executive Health Agent and a member of the Health Department for over 50 years. John rendered distinguished service to MHOA as one of the founders of the Metropolitan Health Officers Association (which later became the Massachusetts Health Officers Association), and its secretary for many years. This award is given annually to a regular member of MHOA, who has contributed to the growth and success of MHOA through outstanding leadership and extraordinary service.

Curtis H. Hilliard Award

This award is in honor of the late Curtis M. Hilliard, one of the founders of the Metropolitan Health Officers Association (which later became the Massachusetts Health Officers Association). Curtis was the Health Supervisor for Wellesley, Needham, and Weston from 1926-1956. He was recognized with honors by MHOA, the American Public Health Association, and the Massachusetts Public Health Association. This award is presented annually to a resident of the Commonwealth who has demonstrated concern for the advancement of public health programs, and has assisted in the delivery of those health services and programs.

Michael D. Saraco Award

This award is in honor of the late Michael D. Saraco, who was instrumental in the formation of the Board of Certification of Health Officers, and was appointed by the Governor to serve on that Board for eight years. Mike was dedicated to MHOA since its inception, and served as its President and Executive Secretary. He was involved with many civic associations and served on numerous health committees and task forces in Massachusetts. Through Mike's dedication, loyalty, friendship, enthusiasm, and leadership, MHOA has grown to be the most prestigious and leading organization for public health in the state. This award is presented annually to a member of MHOA who has exemplified the qualities of the man for whom the award is named.

Sandra Collins Public Health Nursing Award

This award is presented annually to a Public Health Nurse who has demonstrated exceptional dedication in carrying out the public health mandates of a regional or local municipal agency. The award is in honor of Sandra Collins, a past MHOA Board of Directors member and leader in the field of public health nursing both in Massachusetts and beyond. She shared her nursing experience within MHOA, other professional associations, and numerous state and national committees and organizations. She was a strong advocate for the nursing profession in support of local public health.
